# Open Position –Dr. Renato LaRocca Endowed Chair in Oncology Social Work

## The Raymond A. Kent School of Social Work University of Louisville

The Kent School of Social Work at the University of Louisville seeks applicants for our Endowed Chair in Oncology Social Work. Applicant should be a nationally recognized senior scholar/researcher with a currently funded research portfolio. Additionally, the applicant should be able to lead a systematic research program for studying oncology-related issues within community settings and continue to conceptualize, develop, and implement educational programs in psychosocial oncology.

This is a full-time, twelve-month, appointment at the rank of tenured Full Professor position beginning July 1, 2020. The role of the endowed chair is to contribute to a research agenda that advances the quality of cancer care for patients and families/caregivers as well as the strategic interests of UL, Kent School and the James Graham Brown Cancer Center (an Academic Comprehensive Cancer Program at UL). An integral aspect of the chair's responsibility is to secure external funding to support the research agenda for this position. It is also critical for the chair to be able to mentor students focused in this substantive area and assist them, when appropriate, in obtaining external support for their scholarship.

Faculty and staff in Kent School of Social Work study a wide range of issues related to the welfare of children, youth, families and older adults across multiple substantive areas. - --Evidence of commitment to equity and social justice in research/scholarship, teaching, and service
- --Ability to work well with colleagues
- --Successful community partnership experiences

#### **Preferred Qualifications:**

- -- Masters Degree in Social Work
- --At least 2 years post masters experience in practice with populations impacted by cancer
- --Prior teaching experience in oncology social work or a related field
- --Demonstrated research/scholarship, teaching, and service experience with diverse populations
